Bose Frames Audio Tour: Terms & Conditions

1. Participation

The Sculpture by the Sea, Bondi 2019 Bose Frames Audio Tour Prize giveaway competition (the Competition) is conducted by Sculpture by the Sea Incorporated, Suite 302, 61 Marlborough Street, Surry Hills, NSW (the Promoter). Entry to the Competition constitutes acceptance of these conditions. The Competition is only open to an individual who: (a) is a resident of Australia aged 18 years or older; (b) has visited Sculpture by the Sea, Bondi 2019; (c) is not an employee of the Promoter or agencies and companies associated with the Competition; and (d) is not an immediate relative of such an employee.

2. How to enter

- (a) With the assistance of the Promoter, fill out a Bose Frames Audio Tour digital 'Typeform' entry form at the Bose Frames activation site Tamarama Park (Tamarama); and
- (b) use your smartphone to take a photograph, video or boomerang of yourself wearing Bose Frames whilst on the audio tour and upload to social media with the hashtag #BoseFramesSxS

3. Competition duration

Entries must be submitted between 10am 2 November 2019 and 6pm 10 November 2019 (AEST) (the Competition Period). By making an Entry, entrants agree to be bound by these Terms and Conditions. Multiple entries are not permitted.

4. Competition Prize

Five (5) valid Entries will be randomly drawn at the end of each day of activation and will win a pair of unisex Bose Frames, valued at RRP \$299. Twenty (20) pairs of Bose Frames will be given away in total. All entries to the Competition are subject to verification by the Promoter. An entrant must provide to the Promoter copies of documents requested to establish eligibility, including proof of age. If an Entry is ineligible or the entrant is not able to accept a prize, a new Entry will be drawn. Twenty winners will be given a prize (five each day of the Bose Frames Audio Tour). Winners will be notified in writing and/or by phone and/or by Instagram message within 7 days of the Competition Period. Prizes can be collected, otherwise they will be sent by mail (to Australian addresses only). If any prize (or part of any prize) is unavailable, the Promoter, in its discretion, reserves the right to substitute the prize (or that part of the prize) with a prize of approximately equal value. All decisions are final and no correspondence will be entered into.

5. Entries

Every Entry becomes the property of the Promoter. Entries will be used by the Promoter to support the winner's claim to the prize so that the Promoter can provide the prize to the winner and verify their identity.

6. Privacy

Entrants' personal information will be kept confidential and will not be provided to third parties without prior consent, however by entering into the competition the entrant gives the Promoter and Bose permission to use the information provided to develop quantitative data about the exhibition and Bose Frames Audio Tour for use in marketing and promotional materials.

The Promoter is not liable for any loss, damage or personal injury in relation to this Competition or the use of the prize. The Promoter reserves the right to modify, suspend or terminate the competition without notice.
