

Sculpture by the Sea, Cottesloe 2023 Kids' Choice Prize Terms & Conditions

1. Participation. The Sculpture by the Sea, Cottesloe 2023 Kids' Choice Prize competition (the Competition) is conducted by Sculpture by the Sea Incorporated, Suite 302, 61 Marlborough Street, Surry Hills, NSW (the Promoter). Entry to the Competition constitutes acceptance of these conditions. The Competition is only open to an individual who: (a) is a resident of Australia aged 2-15 years; (b) has visited Sculpture by the Sea, Cottesloe 2023; (c) is not an employee of the Promoter or agencies and companies associated with the Competition; and (d) is not an immediate relative of such an employee.
2. How to enter. There are three methods of entering the Competition, an Entrant may: (a) scan a Kids' Choice Prize QR code in our Kids' Guide or on-site at Sculpture by the Sea, Cottesloe and complete the typeform; (b) fill out an online Kids' Choice Prize voting form on the Sculpture by the Sea Incorporated website; or (c) fill out a Kids' Choice Prize voting form within the official Sculpture by the Sea Incorporated App; each of (a) or (c) above being defined as an "Entry". Entries must be submitted by an Entrant between midnight Friday 3 March 2023 and 1PM Sunday 19 March 2022 (AWST) (the "Competition Period"). By making an Entry, Entrants agree to be bound by these Terms and Conditions. Multiple Entries will be permitted by an Entrant during the Competition Period.
3. Kids' Choice Award. The artist who receives the most votes for their sculpture will be awarded \$2,000; announced Sunday 19 March 2023 at 2pm (AWST).
4. Voter's Prize. The first valid Entry randomly drawn will win a Sculpture by the Sea Kids' Prize Pack, valued at \$60. All entries to the Competition are subject to verification by the Promoter. An entrant must provide to the Promoter copies of documents requested to establish eligibility, including proof of age. If an Entry is ineligible or the entrant is not able to accept a prize, a new Entry will be drawn. Three winners will be given prizes. Winners will be notified in writing and/or by phone within 7 days of the Competition Period. Prizes can be collected, otherwise they will be sent by mail (to Australian addresses only). If any prize (or part of any prize) is unavailable, the Promoter, in its discretion, reserves the right to substitute the prize (or that part of the prize) with a prize of approximately equal value. All decisions are final and no correspondence will be entered into.
5. Entries. Every Entry becomes the property of the Promoter. Entries will be used by the Promoter to support the winner's claim to the prize so that the Promoter can provide the prize to the winner and verify their identity.
6. Privacy. Entrants' personal information will be kept confidential and will not be provided to third parties without prior consent, however by entering into the competition the entrant gives the Promoter permission to use the information provided to develop quantitative data about the exhibition for use in marketing and promotional materials.
7. Limitation of Liability. The Promoter is not liable for any loss, damage or personal injury in relation to this Competition or the use of the prize. The Promoter reserves the right to modify, suspend or terminate the competition without notice.
