

Sculpture by the Sea, Bondi 2024 In-App Competition

Terms & Conditions

1. Participation

The *Sculpture by the Sea, Bondi 2024*, Sculpture by the Sea In-App competition ('the Competition') is conducted by Sculpture by the Sea Incorporated ('SXSINC'), Suite 302, 61 Marlborough Street, Surry Hills, NSW ('the Promoter'). Entry to the Competition constitutes acceptance of these conditions. The Competition is only open to an individual who: (a) is a resident of Australia aged 18 years or older; (b) has visited *Sculpture by the Sea, Bondi 2024*; (c) is not an employee of the Promoter or agencies and companies associated with the Competition; and (c) is not an immediate relative of such an employee.

2. How to enter

Method of entering the competition:

(a) **Sculpture by the Sea App**: download the Sculpture by the Sea App to your mobile device and follow the click through to a typeform entry on the Competition in-App 'pop up advertisement'. You will be required to fill out the entry form to be an eligible competition entrant.

Entries must be submitted between 2.00pm Friday 18 October 2024 and 12 noon Sunday 3 November 2024 (AEST) (the Competition Period). By making an Entry, entrants agree to be bound by these Terms and Conditions. Multiple entries are not permitted.

3. Competition Winner

An entry will be randomly drawn from the compiled entry forms and entrants who followed the method of entry as above 2. (a) and will win the Icebergs Dining Room & Bar Prize, described as "Icebergs Dining Room & Bar Tasting Menu with matched wines for six guests". The Prize is valid for lunch or dinner to be used from Monday to Thursday from March 2025 to October 2025. The Prize is valued at \$2500. All entries to the Competition are subject to verification by the Promoter. An entrant must provide to the Promoter copies of documents requested to establish eligibility, including proof of age. If an Entry is ineligible or the entrant is not able to accept the Award, a new Entry will be drawn. The winner will be given a Prize Certificate from which to redeem, and the Winner will be notified in writing and/or by phone within 7 days of the Competition Period. The Prize can be collected, otherwise they will be sent by mail (to Australian addresses only) or email as mutually agreed. If any part of The Prize is unavailable, the Promoter, in its discretion, reserves the right to substitute the Prize (or that part of the Prize) with an alternative Prize of approximately equal value. All decisions are final and no correspondence will be entered into.

4. Entries

Every Entry becomes the property of the Promoter. Entries will be used by the Promoter to support the winner's claim to the Prize so that the Promoter can provide the Prize to the winner and verify their identity.

5. Privacy

Entrants' personal information will be kept confidential and will not be provided to third parties without prior consent, however by entering into the competition the entrant gives the Promoter permission to de-identify the information provided to develop and share quantitative data about the exhibition for use in marketing and promotional materials. The Promoter and Icebergs Dining Room & Bar are not liable for any loss, damage or personal injury in relation to this Competition.

The Promoter reserves the right to modify, suspend or terminate the competition without notice.

7. Privacy Collection Notice

What information is collected?

Sculpture by the Sea Incorporated collects your personal contact information, including your name, phone number and email address. We also collect demographic information, including your postcode, employment description, age bracket and the number of children who attended the event with you.

If you win the Prize, we will ask you to verify your age.

Purpose for collecting information

We collect your personal contact details so that we can notify you if you have won the Prize. If you win the Prize, we are required to verify your age to determine if you are eligible to win the Prize.

We also collect your contact details so that we can send you our e-newsletter or share information about Sculpture by the Sea including Sculpture by the Sea's new Major Automotive Partner DEEPAL Australia. You can choose not to receive our e-newsletter or information from DEEPAL Australia by ticking the appropriate boxes on the typeform. Otherwise, you can unsubscribe from our newsletter at any time by contacting us.

We collect demographic and inbound tourism and expenditure information from you for the purposes of understanding our audience and considering feedback for future exhibitions we hold. This information is de-identified so it is not traceable back to your name and personal contact details.

Sculpture by the Sea is a not for profit organisation and we are not underwritten by Local, State and Federal funding. The information you kindly provide us is used and is necessary to seek much needed funding for the future sustainability of Sculpture by the Sea and the artistic community that we support.

Consequence of not providing personal information

If you do not provide us with all relevant information, or if you choose not to identify yourself, you may be ineligible to win The Prize.

Disclosure of personal information

We do not share your personal information. However, we may share de-identified analytics data with our sponsors.
