## Sculpture by the Sea, Bondi 2025, Kids' Choice Prize Terms & Conditions

- 1. Participation. The *Sculpture by the Sea*, *Bondi* 2025 Kids' Choice Prize competition (the Competition) is conducted by Sculpture by the Sea Incorporated, Suite 302, 61 Marlborough Street, Surry Hills, NSW (the Promoter). Entry to the Competition constitutes acceptance of these conditions. The Competition is only open to an individual who: (a) is a resident of Australia aged 2-15 years; (b) has visited *Sculpture by the Sea*, *Bondi* 2025; (c) is not an employee of the Promoter or agencies and companies associated with the Competition; and (d) is not an immediate relative of such an employee.
- 2. How to enter. There are three methods for entering the competition: (a) fill out a Kids' Choice Prize voting form and put it into one of three voting boxes at the Competition location (Bondi). (b) Vote online at www.sculpturebythesea.com/bondi/vote and (c) vote through the Sculpture by the Sea App. Entries must be submitted between midnight, 17 October 2025 and 9am, 2 November 2025 (AEST) (the Competition Period). By making an Entry, entrants agree to be bound by these Terms and Conditions. Multiple entries will be permitted.
- 3. Kids' Choice Award. The artist who receives the most votes for their sculpture will be awarded \$5,000; announced 2 November 2025 at 2pm.
- 4. Voter's Prize. The first valid Entry randomly drawn will win a Sculpture by the Sea Kids' Prize Pack, valued at \$100. All entries to the Competition are subject to verification by the Promoter. An entrant must provide to the Promoter copies of documents requested to establish eligibility, including proof of age. If an Entry is ineligible or the entrant is not able to accept a prize, a new Entry will be drawn. Three winners will be given prizes (one from each method of entry). Winners will be notified in writing and/or by phone and/or by Instagram message within 7 days of the Competition Period. Prizes can be collected, otherwise they will be sent by mail (to Australian addresses only). If any prize (or part of any prize) is unavailable, the Promoter, in its discretion, reserves the right to substitute the prize (or that part of the prize) with a prize of approximately equal value. All decisions are final and no correspondence will be entered into.
