

## ***Sculpture by the Sea, Cottesloe 2026 Kids' Choice Award***

### **TERMS & CONDITIONS**

#### **1. Participation**

The *Sculpture by the Sea, Cottesloe 2026 Kids' Choice Award* competition ('the Competition') is conducted by Sculpture by the Sea Incorporated ('SXSINC'), Suite 302, 61 Marlborough Street, Surry Hills, NSW ('the Promoter'). Entry to the Competition constitutes acceptance of these conditions. The Competition is only open to an individual who:

- (a) is a resident of Australia aged 2-15 years;
- (b) has visited Sculpture by the Sea, Cottesloe 2026;
- (c) is not an employee of the Promoter or agencies and companies associated with the Competition; and
- (d) is not an immediate relative of such an employee.

#### **2. How to vote and enter**

There are four methods of entering the competition:

- (a) **In Person:** fill out a Kids' Choice Award voting form and place it into the box at the Competition location (Cottesloe);
- (b) **Online:** fill out an online People's Choice Award voting form at <https://sculpturebythesea.com/cottesloe/vote/>; and
- (c) **QR Code:** scan the QR Code located on the Kids' Choice Award onsite signage, within the exhibition catalogue, or on paper voting forms which will direct you to the online voting form <https://sculpturebythesea.com/cottesloe/vote/>.

Entries must be submitted between midnight Friday 6 March 2026 and 10am Sunday 22 March 2026 (AWST) (the Competition Period). By making an Entry, entrants agree to be bound by these Terms and Conditions. Multiple entries will be permitted.

#### **3. Kids' Choice Award**

The artist who receives the most votes for their sculpture will be awarded \$2,000; announced Sunday 22 March 2026 at 2pm.

#### **4. Voter's Award**

Three entries will be randomly drawn from methods of entry as above 2. (a), (b) and (c) and will win a Sculpture by the Sea, Cottesloe Prize Pack, valued at \$250. All entries to the Competition are subject to verification by the Promoter. An entrant must provide to the Promoter copies of documents requested to establish eligibility, including proof of age. If an Entry is ineligible or the entrant is not able to accept the Award, a new Entry will be drawn. One winner will be given a Prize Pack and will be notified in writing and/or by phone within 7 days of the Competition Period. Prizes can be collected, otherwise they will be sent by mail (to Australian addresses only). If any Prize (or part of any Prize) is unavailable, the Promoter, in its discretion, reserves the right to substitute the Prize (or that part of the Prize) with an alternative Prize of approximately equal value. All decisions are final and no correspondence will be entered into.

#### **5. Entries**

Every Entry becomes the property of the Promoter. Entries will be used by the Promoter to support the winner's claim to the Award so that the Promoter can provide the Award to the winner and verify their identity.

#### **6. Privacy**

Entrants' personal information will be kept confidential and will not be provided to third parties without prior consent, however by entering into the competition the entrant gives the Promoter permission to de-identify the information provided to develop and share quantitative data about the exhibition for use in marketing and promotional materials. Please see our Collection Notice below for more information on how we collect and use your personal information.

## **7. Limitation of Liability**

The Promoter are not liable for any loss, damage or personal injury in relation to this Competition or the use of the Award. The Promoter reserves the right to modify, suspend or terminate the competition without notice.

## **8. Privacy Collection Notice**

### **(a) What information is collected?**

Sculpture by the Sea Incorporated collects your personal contact information, including your name, phone number and email address. We also collect demographic information, including your postcode, employment description, age bracket and the number of children who attended the event with you. If you win a voter's Prize, we will ask you to verify your age.

### **(b) Purpose for collecting information**

We collect your personal contact details so that we can notify you if you have won a voter's Prize. If you win a voter's Prize, we are required to verify your age to determine if you are eligible to win the Prize.

We also collect your contact details so that we can send you our e-newsletter or share information about Sculpture by the Sea. You can choose not to receive our e-newsletter by ticking the appropriate box on the voting form. Otherwise, you can unsubscribe from our newsletter at any time by contacting us.

We collect demographic information from you for the purposes of understanding our audience and considering feedback for future exhibitions we hold. This information is de-identified so it is not traceable back to your name and personal contact details.

### **(c) Consequence of not providing personal information**

If you do not provide us with all relevant information, or if you choose not to identify yourself, you may be ineligible to win a voter's Prize.

### **(d) Disclosure of personal information**

We do not share your personal information. However, we may share de-identified analytics data with our sponsors.

### **(e) Do we share your information outside Australia?**

We do not share your personal information outside of Australia.
